After school returning to school around 12:30am (Saturday)**

Trip includes: Five plus hours of skiing at Alpine Valley Mountain- **Cost per person \$37**

Optional cost:

Coach bus: Cost \$20 Per person

Round Trip Transportation from Lincoln Middle School to Alpine Valley (W2501 County Road D, Elkhorn, WI) a light snack and drink will be provided on the bus.

Meal Option: Cost \$10 Per Person- or Student can bring own sack lunch/ money
-Choice of cheese, pepperoni, sausage pizza and Soda

Equipment Rental: Cost \$32 per person

Price includes Ski/board equipment and helmet. All students are required to wear helmets. If bringing a helmet from home, the cost of rental is reduced by \$10 to \$22.

Lessons: Cost \$5 per - Participant must be over 7.

It is strongly recommended that all students take a lesson. It is required for students who are below an intermediate ski level. That is any student who doesn't ski several times a year and isn't very confident at stopping and keeping control on the slope.

Chaperones: We will have 1 chaperone for every 10 students, who are not on the trip with their family. The Chaperone will receive transportation, rental, ski/boarding and meal ticket at no cost, unless otherwise requested. We will use Lincoln Staff first and then parent volunteers as needed.

Chaperones are responsible to make sure the students get on the bus at the proper time, get and return equipment, attend lesson, check in with the student during the day, and supervise the student's general conduct.

I FREELY ASSUME ALL RISKS OF INJURY ASSOCIATED WITH SKIING

I understand that the boot/binding system which I have rented is designed to reduce the risk of certain injuries to the lower leg. It will not release at all times, nor under all circumstances where a release may prevent an injury, not is it possible to predict every situation in which it will release. I understand the boot/binding system therefore does not guarantee any safety.

I further agree and understand that although the boot/binding system that I have rented may reduce the risk of certain injuries to the bones of my lower leg, it will not at all reduce the risk of injury to my knees or other parts of my body in the event of a backwards fall.

I accept for use in its AS IS condition the equipment listed on this form and accept full responsibility for its care while in my possession. I will be responsible for the replacement, at full retail value of any equipment rented from Alpine Valley Resort, Inc. under this agreement, which is not returned.
